The council looked at Grover's findings on the sewer numbers he complied from Jessica's data. The numbers show currently the residents pay 43.3% of the revenue to the sewer, 17.6% by the commercial accounts and with Bobcat at 39%. When looking that the water usage it shows that Bobcat is at 60%, residents at 25.3% and commercial at 14.1%. The 4% increase to all accounts would be a projected revenue increase of \$3607.56. At the end of 2014, the sewer fund is at a -\$51,971.76. The council is looking at ways to not increase the low users but the ones using more water. One option was to have the residents that is using over the 3000 gallons be increased 10% along with the commercial users, and Bobcat base rate increased by 20% and with a \$.50/ 1000 gallon usage fee. With these increases the projected revenue increase would be \$28,098.90.

After much discussion, the council directed Grover, Dan, Chris, Dennis and Jessica to meet with Bobcat on the proposed increase. That meeting will be held on February 26<sup>th</sup> at 2pm at Bobcat.

Sewer increase was tabled until council meeting on March 2<sup>nd</sup> meeting.

Linda did make a motion to approve the resolution declaring work necessary for water system improvement district No 14-1. Chris seconded that motion and all ayes with present council, Jerry was absent.

Linda made another motion to approve the resolution declaring work necessary for sewer system improvements district No. 14-2. ElRoy seconded the motion and all ayes with present council, Jerry was absent.
