First layout will present and will go from there. Lisa Lemann was offered the lease agreement for the community center. Move in Houses: Jerry came forward with some information on a builder that builds a lower family income houses. 1011 square feet per floor house with two bedrooms that would include a refrigerator, electric stove, Micro-hood and dishwasher included.
