Auditor Report: 2016 Budget was finalized. General Fund is at 126.20 mills at the amount of \$250,380.80, Emergency Fund is at 2.50 mills at the amount of \$4960, Airport Fund is at 4 mills for the amount of \$7936, and the City Specials are at 14.20 mills at the amount of \$28,172.80. Total amount levied is \$291,449.60 with 146.90 mills. Linda made a motion to approve the budget as is and Chris seconded the motion and all ayes. The final 2016 budget will be sent to Sargent County Auditor. **Public Works Report**: Dennis had a quote to mill and remove old blacktop. Bituminous Paving, Inc. quoted \$180.00 per ton and Dennis thought there was approximate 90 tons to do so \$16,200 in total.

Chris made a motion to approve the quote and it to be paid out of the street fund and Linda seconded the motion and all ayes. Any residents that have to dig up the streets due to sewer issues will have to personally pay for the street to be fixed. Dennis will talk to the resident, which needed to dig up the street to get the sewer fixed on his home at 132 Maplewood Drive.

Dan McKeever opened up the meeting. This is public meeting to increase the 1% city sales tax and use tax starting on January 2016. There are four large projects that this money would go towards. The first one would be to help develop nine to ten lots in the GCDC 1st Addition including paved roads, curb and gutter for the amount of \$950,000. The goal would be to have about \$25,000 per lot for specials. The second project would be to help develop the Fairway Addition on the south side of town. That would create large lots for large homes and that is estimated to be around \$750,000. The third project would be the activity center at the school and at this point there is estimate but could be from \$500,000 to \$2 Million dollars. The fourth project would be the North Sargent Pool. At this time, the pool needs serious help if we want to open in 2016 the way it is. An outdoor pool could cost around \$1.8 Million and up, depending on what we do. There has been more talk around town, about an indoor pool attached to the school; Mr. Cale at the school has said he would be open to looking into that. Currently, the one percent city sales tax and use tax averages about \$350,000 a year. Dan, mention if we did a five million dollar bond at two percent it would be around \$300,000 a year for a payment. There were great conversations with all present. No second motion made at this time.
