Gwinner Park Board: Paul Detloff resigned as President due to moving to MN. Pool issues meeting on Sept 23rd to see what should be done.

Gwinner Airport Authority Board: Mark E Bopp has resigned as of October 1st, 2015. Airport authority will appoint a member.

Auditor Report: Jessica presented the Preliminary Budget for 2016. Harold was present to explain the changes this year. Last year the mills were at 147.80 and this year it looks to be at 146.90 at a total of

\$291,449.60. The city will have lower mills than last year. Public meeting is needed for the new renaissance blocks and the sales tax increase. The public meeting will be on October 5th at 4:30pm for the new renaissance blocks. The council signed the Sargent County Bank NetTeller Application for online statements. The council looked over the Verizon wireless tower and building. They are going with a smaller building (6x6) with an external generator and a chain link fence. The council proposed a privacy fence (vinyl) instead of a chain link fence and approved it otherwise. (EIRoy, Jerry) The 48" culvert with manhole was quoted at \$12,873.54 by the city shop and the Dakota View Apartments. \$10,000 will come out of the Street fund and the rest out of the sales tax fund.

Public Works Report: Dennis reported the main water tower is being filled and cleaning and sanitizing the water. Will need to test the water and then get it back online. The well new drill is drilled. The water main valve in Maplewood is now installed. Construction plans for the water plant are continuing. The storm drain project in the GCDC is complete. Dennis also provided a need list for 2016 budget.

Mayor Dan opened the meeting up and had two items to go over issues with the pool and the Superintendent Position. Steve Morlock shows the group the crack that goes from the roof to the foundation, the shingles on the roof are bad, corrosion in the filtration room (chemical room) eating a hole in the concrete, one of the filtration units can't get parts and filters any longer, condensation dripping from pipes onto the electrical conduit and water leaks out of the main pool and the kiddie pool. Chris and Dan went into the main pool and Chris tapped along the floor of the pool and found it to be hollow under the concrete. There is bowing the walls of the pool where the anchors have been broken lose. As it seems, the pool is unlikely to open next year until some major repairs are done. Dan asked the question, Is this an \$100,000 fix that will give us another 10 years or is it time for a new pool sooner than later. The park board couldn't answer that question at this time, but said they have been trying to get Olson Pool and Tub of Fun to come out and see what can be done if anything, for the last 3 months. The pool is 21 or 22 years old. The trees are all dying around the pool, due to all the chemical draining out of the pool. A state inspector should do a safety inspection of the building to make sure we are up to code.

City Superintendent was the next thing on the agenda. The council stated by going over the job description that Jessica

City Superintendent was the next thing on the agenda. The council stated by going over the job description that Jessica provided for them. They added a couple of things and then they wanted to make sure the applicant is aware there is on call activities from time to time and we need to make that clear up front. Health insurance will be included, along with a company truck and cell phone. Applicant will need to live in the city limits. There will be weekend work also. The position will start at \$18.00 an hour. Depending on if they have certain water and wastewater certifications, they could go up from there. The position will be advertised until October 31st. Interviews will be done in November and December and hope to have it narrowed down in January. This person will train with Dennis for most of the 2016 year. Jessica will get the help wanted ad out to JOB SERVICE of ND, the Teller, and The Gazette.
